The Women's Art Resources of Minnesota announces a call for entries for our 2012 juried member exhibition at the Grain Belt Bottling House. There is no theme this year. All current WARM members may submit images of up to 3 works of art completed within the past three years for consideration. First, second and third place prizes will be awarded.

**Announcing our 2012 Juror: Mason Riddle**

Twin Cities based writer/curator Mason Riddle covers the visual arts, architecture, craft and design. Her work has been published in the Star Tribune, Architecture MN, Dwell, Architectural Record, Ceramics: Art & Perception, Elle Decor, Artforum, Public Art Review, Sculpture Magazine, Surface Design and Rain Taxi, among others. She is the former director of the MN Percent for Art in Public Places program, Interim Director of the Goldstein Museum of Design and visual arts critic of Intermedia Arts MN.

1 - 3 jpeg images of your artwork, one detail image permitted if necessary (see guidelines)

Artist's Statement in word or PDF format, 300 word maximum

### Documentation of Work Guidelines:

Submit 1-3 images in jpeg format on cd/dvd or via email attachment. Images must be labeled with last name and first initial (example: doej1.jpeg), in jpeg format at 72 ppi and a maximum length of 1920 pixels on the longest side. Number artworks corresponding to the information you fill out in the entry form for artwork 1, artwork 2 and artwork 3. CD/DVD submissions must be labeled with artist's name and include a printed image inventory page along with a word file on disc listing title, medium, and size.

### Video & Digital Media

Provide 1-3 digital work samples via web link or on DVD with total view time of no more than 10 minutes. Label DVD and case with your name and include an inventory page or file with titles, medium, price, run time, and date. Include a description of installation requirements; video artists must provide their own equipment and be available to assist WARM with installation. Video artists should keep in mind there will be no gallery attendant available to operate DVD players at the Bottling House.

### Artist's Responsibilities (\*Agreement to this is required at the bottom of entry form)

Work must remain on view for the duration of the show. Although WARM carries minimal insurance in order to use the space, artwork is considered to be on display at the artist's own risk. If artwork has special installation requirements, the artist is expected to assist the committee with installing. WARM collects a 30% commission on works sold. WARM cannot be responsible for unclaimed artwork after May 5th, 2012.
